b. Consideration of funding for engineering costs for trail extension between Dendrinos Drive and Cass/South Airport (6:15)

Julie Clark said this proposed sidewalk connection was identified in the preliminary design and has now been formalized as a way to connect NMC and the BATA transit station. The trail supports Garfield Township's non-motorized plan and would complete the Boardman Lake Loop Trail from 14th Street to the Cass Rd/South Airport intersection. The City of Traverse City has applied for a MDOT grant to fund construction of the trail, but the engineering needs to be completed before the grant can be submitted. Clark is asking for \$20,000 from Garfield Township for Prien & Newhof's engineering services related to the portion of the Boardman Lake Loop located in Garfield Township. Korn said that the money would come from the Cable Funds. Board members asked for a spreadsheet of costs to the Township related to the Boardman Lake Trail to this point which Clark will provide.

Agostinelli moved to approve engineering costs for a trail extension between Denindros Drive and Cass/South Airport and that money be taken from the cable funding public service dollars. Blood Law seconded the motion.
