**AMENDMENT NO. 2 TO ORDINANCE NO. 50  
PARKLAND ORDINANCE**

**PLEASE TAKE NOTICE** that the following proposed ordinance amendment was introduced at a meeting of the Garfield Township Board on the 23rd day of April, 2019 and that the same will be the subject of Public Hearing and consideration of passage by the Garfield Township Board at its meeting to be held on May 14, 2019 beginning at 6:00 p.m. at the Garfield Township Hall, 3848 Veterans Drive, Traverse City, MI 49684. The Township's telephone number is 231-941-1620.

An amendment to Ordinance 50 AMENDING:

Section IV. Prohibited Activities: adding Line L AND RE-LETTERING M,N,O,& P. The following activities are prohibited and it shall be unlawful for any person or persons to do any of the following in Township Parkland;

**L. To possess, smoke, or vape marijuana on Township Parkland.**

AND amending Section V. Rules of Operation, Item D

D. No smoking **or vaping** of tobacco products of any kind is permitted within 100 feet of any playground equipment, pavilions, restroom facilities or any other area where persons may be affected by second-hand smoke.
