**AMENDMENT NO. 1**

An Ordinance to establish the office of Ordinance Enforcement Officer; to prescribe the duties of said office; to authorize the Township Board to appoint any person or persons to said office; and to amend any Ordinances of The Charter Township of Garfield which conflict with the provisions hereof.

**Amendment No. 1**

Section 4 of the Garfield Charter Township Ordinance Enforcement Officer Ordinance is hereby amended to read as follows:

Section 4. Definitions

The Ordinance Enforcement Officer's duties herein authorized shall include, among others, the following: Investigation of Ordinance violations; issuing and serving ordinance violation notices; issuing and serving appearance tickets as authorized under Public Act 147 of 1968, as amended; issuing and serving municipal civil infraction violation notices and municipal civil infraction violation citations as authorized under 1994 PA 12, as it may from time to time be amended; appearance in court or other judicial or quasi-judicial proceedings to assist or otherwise administer the prosecution of Ordinance violators; and such other Ordinance-enforcing duties as may be delegated by the Township Board or the Township Supervisor.

This Amendment No. 1 to Garfield Township Ordinance No. 20 shall take effect thirty (30) days after publication.

A copy of the Ordinance, including this Amendment No. 1, may be purchased or inspected at the Township Hall, 3848 Veterans Drive, Traverse City, Michigan, between the hours of 9:00 a.m. and 4:00 p.m., Monday through Friday.
