## 5. <u>Business to Come Before the Commission</u>

## a. PD 2018-59 Silver Lake Recreation Area Landscape Buffer

Commissioners looked at the land where many invasive species trees were taken out and determined that a new buffer needed to be placed to protect the neighboring properties from seeing the activities in the park. Tom Vitale and commissioners discussed which type of buffers would be adequate for the area and Larrea said that the ordinance approved a Type C buffer in that area.

DeGood moved and Schmuckal seconded THAT the planting of a "Type C" buffer at the Silver Lake Recreation Area along East Silver Lake Road in accordance with Section 531 of the Zoning Ordinance to replace the recently removed invasive vegetation BE RECOMMENDED to the Township Board.

## b. PD Report 2018-60 Silver Lake Recreation Area Path Crack Filling/Benches

## Grand Traverse Conservation District August 2018 Report

#### **CONSERVATION TEAM**

#### OWNER/PARKLAND: Garfield Township - Various

#### Administration

- Continued to work with a property owner on Miller Creek to potentially add to Miller Creek park as an access off Cass Road.
- Attended and provided updates at monthly Parks and Recreation Commission meeting.

#### **Routine Monitoring and Maintenance**

- Monitored trails and trailheads at all Garfield parklands, replaced dog waste bags at trailhead dispensers, and picked up trash as necessary.
- Cleared trails and removed down trees by chainsaw following late August storm events at all Garfield parks (Commons was hit especially hard).
- Replaced vandalized interim trail maps at the Commons trail intersects.
- Mowed, weed whipped, and pruned along trails as necessary.
- Replace dilapidated railing on fishing/viewing platform at Boardman Valley Nature Preserve.
- Replaced damaged footbridge railing at Miller Creek crossing down from Aldi Foods.
- Secured railing and bench along boardwalk at Kid's Creek Park.
- Removed or replaced damaged fencing at trailheads as appropriate.
- Installed a new trash surround at Silver Lake Recreation Area and removed the old one.
- Repaired two trail erosion sites at Silver Lake Recreation by implementing water bars, check dams, and aggregate.
- Installed erosion control measures near creek crossing at the Commons along Cedar Cathedral Trail.
- Contracted YouthWork to remove aquatic weeds at Oleson Pond at Kid's Creek Park.
- Switched garbage totes at Silver Lake dog park on a regular basis to accommodate dog waste disposal needs.

#### Other

- Coordinated the Invasive Species Network on the treatment of invasive phragmites at Miller Creek Nature Reserve and Kids Creek Park.
- Coordinated the Invasive Species Network on the early detection and treatment of invasive callery pear on the hill top at the Commons.
- Coordinated and assisted Boardman River Clean Sweep in homeless site clean-up efforts at River East RA and on the Verizon parcel at Boardman Valley Nature Preserve.
- Sought tree stock at local nurseries for Silver Lake RA buffer along E. Silver Lk. Rd.



### OWNER/PARKLAND: Recreational Authority - Hickory Meadows

#### Administration

- Attended and prepared the agenda for the monthly Hickory Meadows Advisory Committee (HMAC) meetings.
- Attended and provided updates at the monthly Rec Authority Board meeting.
- Corresponded with Derek Melville, TC Superintendent of Parks and Recreation, and Spence Brothers, contractors for Hickory Hills developments, on updates and anticipated commencement of drain field construction on Meadows property.
- Contacted landscaping contractors to determine feasibility and cost of mowing the meadows.
- Contacted nurseries to determine available stock for buffer planting.

#### **Routine Monitoring and Maintenance**

- Monitored all trails and trailheads, picked-up trash, and replaced dog waste bags as needed.
- Removed several down trees along trails following late August storms.
- Pruned trees and shrubs along trails as necessary.
- Mowed and weed whipped trailheads and trails.
- Notified camper near the mid-Randolph maintenance access of no camping regulations on Meadows property.
- Downloaded trail counters for review and analysis.
- Continued to supply, collect, and record user surveys at main trailheads.
- Monitored erosion concerns on Meadows property resulting from Hills work site.
- Replaced a broken 'No Parking' post at Historic Barns Park.

#### Grants

 Awarded \$3,000 from the DTE Energy Foundation Tree Planting Grant Program to assist in the buffer planting along the Hickory Meadows and Hills border. Grant expires May 31, 2019. This will enable purchase of larger diameter trees in addition to the City's planting plan along with secured restoration funds provided by NW MI Invasive Species Network.

#### **BOARDMAN RIVER STEWARDSHIP**

- Met with Senator Wayne Schmidt, Garfield Township Supervisor Chuck Korn, and others
  regarding how to get the railroad more involved in the replacement of the perched culvert under
  the railroad. GTCD staff helped arrange for a \$200,000 EQIP grant through the Grand Traverse
  Band to assist with the replacement.
- Conducted a Community Stewardship float through the new section at Brown Bridge.
   Backcountry North provided the use of the kayaks.
- Coordinated and conducted a site visit for project partners re: Phase-II instream habitat wood at Brown Bridge funded through a USFWS grant.
- Assisted with a tour for the Great Lakes Fishery Trust's 20<sup>th</sup> anniversary celebration through the new section of River in the Boardman bottomlands.
- Prepared the Final Report for the 14<sup>th</sup> Annual Boardman River CleanSweep.
- Responded to reports of trees down blocking the river from several storms that blew through the area during the previous week.

#### **STAFF COMMENT:**

Landscaping and Irrigation for Silver Lake Road Buffer Area:

At the last meeting of the Parks and Recreation Commission, Commissioners unanimously passed the following motion regarding the landscape buffer along Silver Lake Road:

DeGood moved and Schmuckal seconded THAT the planting of a "Type C" buffer at the Silver Lake Recreation Area along East Silver Lake Road in accordance with Section 531 of the Zoning Ordinance to replace the recently removed invasive vegetation BE RECOMMENDED to the Township Board.

However, since that time, the circumstances surrounding the buffer have clearly changed, in particular that a much larger area of planting is now required. Therefore, the Commission should discuss whether they still think that a "Type C" buffer is appropriate or whether other options should be pursued.

As for possible irrigation of the buffer yard, it appears that a good place to start in determining its feasibility would be contacting the contractor for the existing system to determine whether it has additional capacity or whether it might be added at a reasonable cost.
