establishes and designates the City Manager of the City of
Traverse City as the person to exercise those powers and perform
those duties held by or incumbent upon the Supervising Agency
pursuant to the Urban Redevelopment Corporation Law, being Act 250
of the Public Acts of 1941, as amended (MCLA 125.901, et. seq.),
to the extent that such powers and duties are enumerated or
limited by the same.

This Ordinance shall take effect on the 31st day of
August, 1993.
