

Please join us in congratulating *Abby Abbott* for obtaining her Michigan Certified Assessing Officer (MCAO) certification from the State Tax Commission! She has worked hard and has proven to be an asset to our department and our taxpayers. Job well done!

The lack of housing inventory has kept home prices moving upward. Demand continues to outpace supply – much like areas all over Michigan and the country. Garfield Township has not had the home value decreases in 2024 as many expected; however, there are some areas in our state which have started to see the number of foreclosures rise. <u>US News Real Estate</u> predicts the housing market will likely thaw in 2025, but the number of sales will remain low.



2025 may be a better year to buy a home though. Mortgage rates are expected to go down more, which should help affordability and bring more sellers back to the market which should help increase supply. For sellers, the decision may be tougher – especially if there is any downturn. Spring 2025 could bring changes in the real estate market, but no one knows for sure.

Whatever happens, rest assured that the Garfield Township assessors are keeping an eye on sales. It is our job to study property sales and examine things further when we start seeing changes. The studies we perform analyze the market and all of its changes and help us determine the values that are assigned to properties throughout the Township.

SMALL BUSINESS TAXPAYER EXEMPTION – 2025 update!

Before 2023, the asset limit was \$80,000 to be exempt from Personal Property taxes – it is now \$180,000 - an increase of \$100,000! This is great news for small business owners! If your business has <u>assets worth no more than \$180,000</u> (total true cash value, calculated using the normal Personal Property depreciation multipliers) in Garfield Township as of 12/31/2024, be sure to watch your mail for details! This higher threshold <u>may</u> mean **NO PERSONAL PROPERTY TAXES** for your business! Forms for 2025 will be mailed at the end of the year – make sure to get the appropriate form(s) back to us no later than <u>February 20th</u>. If you filed Form 5076 in February 2024 or before, chances are you don't have to file again but don't assume that– contact us to be sure to verify everything is in order. FROM THE PLANNING DEPARTMENT

BATA Headquarters Opens; Meadow Valley Nears Completion

Over the past few months, two of the largest projects reviewed by the Planning Department and Planning Commission in recent years made significant progress completing their construction. The headquarters of the Bay Area Transportation Authority (BATA) opened in September 2024 at the corner of LaFranier Road and Hammond Road. On the west side of the Township, the Meadow Valley senior living complex is nearly complete with construction.

Both projects were reviewed using the Planned Unit Development (PUD) process. The PUD process allows the Township to consider some flexibility in regulations where mixed or varied uses are proposed that could not be achieved under a single zoning district, innovation and variety of design, additional amenities, or a substantial public benefit. BATA is partnering with Traverse City Housing Commission (TCHC), which is constructing workforce housing on the site along with BATA's transfer station, which offered the unique benefit of pairing workforce housing with transit. Meadow Valley's development includes different types of housing such as independent living, assisted living, and memory care; a future phase of the development envisions 33 single-family homes adjacent to an existing single-family neighborhood.

Both projects include sidewalks and trails which support a more connected non-motorized transportation system as described in the Township Master Plan. Several new developments along LaFranier Road such as BATA, Prince of Peace church, Ridge45, and Village at LaFranier Woods have created a more complete sidewalk network on LaFranier Road. Meadow Valley's site includes a shared-use trail which is envisioned as part of a larger connection between Traverse City West Senior High School and other regional trails.

Stop by the Planning Department during our regular office hours or attend a Planning Commission meeting (typically scheduled for the second and fourth Wednesdays of the month at 7:00 PM at Garfield Township Hall) to learn more about what's happening with new development around the Township.

The 2024 Election Cycle was a huge success in Garfield Township. Early Voting started slow with the first two elections but exploded with the General Election in November. We had 3192 voters in the nine days before the November 5th Election. We also had 5732 Absentee Ballots returned. This helped alleviate long lines on Election Day. There was a steady line all day but no long waits. We would like to acknowledge all the Election Inspectors that stepped up to work extra days for Early Voting and all of their hard work throughout the Election Cycle. We wouldn't be successful without them.



FROM THE TREASURER'S OFFICE

Amy Simon is currently the Deputy Treasurer at Garfield Township and has served the residents of Garfield for seven years. In April of this year, Amy completed her third year of classroom education that certifies her as a Michigan Certified Professional Treasurer (MiCPT).


FROM THE PARKS DEPARTMENT

Buffalo Ridge Trail

The tree planting of 2023 along portions of Buffalo Ridge Trail (behind the new YMCA) suffered some loss from early drought (despite watering efforts). The good news is, the Conservation Resource Alliance was able to establish some additional grant funding that will allow for replacement trees this fall. On the flip side, several of the trees are doing well and are growing right through the top of the planting tubes!

The Commons

Plans are in the works and funding is in place to establish a new trail head to enter The Commons from behind the Copper Ridge Surgery Center (A). A trail will be created from this area to link trail users to the existing trails. We are asking trail users not to park behind West Front Primary Care (B) as this is the parking lot for patients and employees of West Front Primary Care Only. A temporary parking location is located southeast of the West Front Care building (C). See map below.

ATTENTION SILVER LAKE RESIDENTS – Milfoil Special Assessment

Due to the sufficient balance in the milfoil special assessment account, Garfield Township will not be billing for milfoil this year on your 2024 winter tax bill. The last milfoil assessment was approved and billed for 2019-2023, so a renewal will need to happen this year to bill starting again on your 2025 winter tax bill. Look for information about public hearings for establishing a new special assessment district this year.

Eurasian Water Milfoil (EWM) an invasive aquatic plant that out-competes native plants and will overwhelm a lake if not controlled. It has been spreading across the U.S. for decades and appeared in Silver Lake in 2005 and has been treated on Silver Lake ever since.
